

WWW SURVEY CONTEST RULES

1. Eligibility. NO PURCHASE NECESSARY. This Contest is open to legal residents of the United States, who are eighteen (18) years or older at the time of entry and reside in the United States. Void where prohibited by law. Employees of All Bright Maintenance Services and those involved in the development, production, implementation, and distribution of this Contest, and their advertising and promotion agencies, service providers, parent companies, employees, agents, officers, subsidiaries, or affiliates, or any other persons or entities directly associated with this Contest and members of the immediate families and/or any persons living in the same household as such persons are ineligible to enter the Contest.
